Full Time artist will be required to submit a minimum of 1 drawing per month, & will be required to provide (3 campaign submissions per year) for freeflow (Campaigns are sent monthly & include certain topics E.g. sports stars, talk show hosts, cars, etc.) **All Artists will also receive \$200.00**. A One time payment Once their art hits **(30) Thirty sales**.

- **Delivery & Condition:** The Artist shall be responsible for the delivery of the Works listed & titled above to Freeflow. All costs of delivery (including transportation & insurance, shall be paid by the Artist.
- **Royalties:** Freeflow Art agrees to pay the Above Artist in this said contract, a **Royalty of \$5.00** Five Dollars for each & every individual sale including the artists art, with a total Net Sale of \$25.00 Twenty Five Dollars or more. Any individual Sale including the artist art, with a Net Sale under \$25.00 Twenty Five Dollars or less, will be paid a Royalty of \$1.00 One Dollar. Net Sales as used herein shall mean, sales to customers, less credits for lawful & customary volume rebates, actual returns, & allowances. Royalties shall be deemed to accrue when the Freeflow Art products are sold featuring the Artists Artwork.
- **Independent Contractors:** The Artist shall perform his/her Work under this contract as an independent contractor & NOT as an Employee of Freeflow Art. As such, said Artist will be responsible for any & all scheduled payments of Federal & State Income Taxes due as an Independent Contractor, NOT as an employee of Freeflow!
- **Payments & Statement of Account:** All Payments, including flat fees & all Royalty Payments, shall be paid monthly on the 1st day of each month, commencing the day the art is 1st featured on the Freeflow website. Freeflow shall with each Payment, furnish Artist with a monthly “Statement of Account”, showing the kinds & quantities of All the Freeflow products sold, featuring the Above Artists Art. The Above Artist shall have the right to terminate this agreement upon written notice if Freeflow fails to make any payment required of it.
- **Promotion:** Freeflow Art shall use its best effort to Promote, Distribute, & Sell the Artists Works.
- **Reservation of Rights:** All rights Not specifically transferred by this agreement are Reserved by Freeflow.
- **Nature of Contract:** Nothing herein shall be construed to constitute the parties hereto as “Joint Ventures” nor shall any similar relationship be deemed to exist between them.
- **Address:** All Notices, Demands, Payments, Royalty Payments, & Statements shall be sent to the Above Said Artist at the following ADDRESS: _____
- **Governing Law:** This Agreement shall be Governed by the Laws of the State of Arizona.
